Dr. Edward Glab

Director, Global Energy Security Forum, FIU

Dr. Glab has a background in international business, education, media, and government service, including USAID and the Peace Corps. He was with Exxon-Mobil for more than 25 years and held a variety of positions in public affairs, including political risk; government and community relations; new business development; media relations; corporate and marketing advertising, and emergency response, among others. Associate Professor and Graduate Program Director of the Earth and Environment Department, FIU

Louise Léger

Consul General, Consulate General of Canada in Miami

Louise Léger (BSc [Economics], Université de Moncton, 1980) joined the Department of Industry, Trade and Commerce as a trade commissioner in 1981. Her career at Foreign Affairs and International Trade Canada has included postings to Colombia, Switzerland and Israel. In 1995, she was appointed ambassador to Panama, and in 2001 ambassador to Costa Rica, with concurrent accreditation to Nicaragua and Honduras. In Ottawa, Ms. Léger has held the positions of deputy director of the Eastern Europe Commercial Relations Division as well as executive director and deputy director general at the Summit of the Americas Bureau. Ms. Léger has also twice served as director general of Trade Commissioner Service, leading the Operations Bureau as well as most recently the Client Services Bureau. Ms. Léger began her tenure as Consul General of Canada in Miami in September 2009.

Dr. John Parker

Professor Emeritus of Environmental Science and Chemistry, FIU

John H. Parker is a Founding and Emeritus Professor of Environmental Science and Chemistry at Florida International University in Miami, FL. He Received a B.S. in Chemistry from Emory University and a Ph.D. in Physical Chemistry from the University California at Berkeley. His research interests focus on ecological landscaping, passive solar cooling, energy and resource conservation, energy policy and environmental education. Dr. Parker received American Forests' Research Medal for his pioneering studies of energy conservation landscaping, the Distinguished Service Award from the Florida Board of Regents for his work in the community and the FIU Service Medallion for over 35 years of outstanding university service.

CEO, First Nations Band, Fort McKay

To add to his successful working career, Jim has served 9 years as a school trustee, 15 years as councilor with the Regional Municipality of Wood Buffalo, 10 years as Resource Development Chairperson, and 2 years as Deputy Mayor.

Jim has a Bachelor of Education and a Diploma in Intercultural Education. Jim is married to his wife Geraldine and they have three children: Sean, Sarita and Fergus and four grandchildren.



David McLaughlin

President and CEO, National Roundtable on The Environment and Economy (NRTEE)

David McLaughlin has over 25 years of experience as a senior public policy professional at both the federal and provincial levels of government.

He began his career as a policy assistant to the Minister of Health and Social Program Reform in the New Brunswick government from 1980 to 1984.

He then worked in the federal government as Senior Policy Advisor and Chief of Staff to a number of federal cabinet ministers.

In 1992, he joined the Prime Minister's Office as Senior Advisor, Operations, before being appointed Chief of Staff to the Prime Minister in 1993.

From 1994 to 1999, Mr. McLaughlin worked in the private sector as Partner and Executive Vice President of Veritas Communications Inc., a healthcare communications firm.

In 1999, he joined the New Brunswick government as Deputy Minister of Intergovernmental Affairs (2001) and Deputy Minister of Policy and Planning (1999-2003). In 2000, he was also appointed as Secretary to the Cabinet Committee on Policy and Priorities. He served as Chief of Staff to the Premier of New Brunswick in 2003.

In 2003, Mr. McLaughlin was appointed as Deputy Minister to the New Brunswick Commission on Legislative Democracy, an independent, non-partisan commission examining democratic reform.

In May 2005, the Premiers of Canada's provinces and territories announced the creation of the Council of the Federation Advisory Panel on Fiscal Imbalance, and Mr. McLaughlin was hired as the Panel's Executive Director.

From March 2006 to August 2007, Mr. McLaughlin served as Chief of Staff to the federal Minister of Finance.

David has a B.A. degree with Honours in History and Political Science from Mount Allison University in Sackville, New Brunswick (1978), a M.A. degree in International Affairs from Carleton University in Ottawa (1980), and a M.B.A. degree from the University of Bath in the United Kingdom (1991).

Mr. McLaughlin is a published author. He is an Honourary Fellow of The Royal Canadian Geographical Society.

Dr. Mahadev Bhat

Professor and Associate Chairperson of the Earth and Environment Department, FIU

Dr. Mahadev Bhat is Professor of natural resource economics in the Departments of Earth and Environment and Economics at Florida International University. Dr. Bhat has been conducting economics and policy research for the last twenty years in the broad area of natural resources. Specifically, his past research addressed issues related to bioenergy, forest resources, groundwater, and environmental pollution. The over-all goal of his research was to identify ecologically sustainable and economically efficient management policies. At present, Dr. Bhat, along with graduate and undergraduate students, is researching on emerging bio-energy technology in India. Funded by the US Department of Agriculture's International Science Education Program and conducted in collaboration with two agricultural universities in India, Dr. Bhat and his research team are trying to understand the biofuel production technology, institutions and market developments, and government policy interventions in developing countries. His research projects have received funding from the US Department of Agriculture, US Agency for International Development, Everglades National Park, the World Bank, the Government of India, Ford Foundation and Stanford Development Group. He has more than 150 publications, including referred journal articles (30), conference publications, research reports, book chapters and guest lectures. Dr. Bhat co-leads ongoing FIU Agroecology Program. He routinely serves as a referee for several professional journals and is on the Editorial Board of the Journal of Sustainable Agriculture. Dr. Bhat received his Ph.D. in agricultural economics (with specialization in natural resource economics), from the University of Tennessee and master's degree in the same area from the University of Agricultural Sciences, Dharwad, India.
